Dear BBA Applicants for Academic Year 2020 – Inter Portfolio 2

Pursuant to the continuous and extensive spread of coronavirus 2019 (Covid-19) all over the world, on March 11<sup>th</sup>, 2020, the World Health Organization (WHO) declared the outbreak a “pandemic” in the global scale. Moreover, on March 21<sup>st</sup>, 2020, the Bangkok Metropolitan Administration (BMA) has ordered the temporary closure of many places from March 22 to April 12, including all types of educational institutions (according to Item 15 of the BMA Announcement). To reduce infection risks for lecturers, staff, and students from density in Bangkok and vicinity, which may help prevent the spread situations from developing to Stage 3, Thammasat University has notification on Measures and Suggestions on the Prevention and Control of Coronavirus 19 (COVID-19) (No 8) according to Item 4 of the Announcement there will be no admission exams for both undergraduate and graduate degrees during 22 March – 12 April 2020, except for online exams.

Due to the Notification by Thammasat University (No. 8), Thammasat Competency Test Center (TCTC) cancels its GSAT administration scheduled on March 29<sup>th</sup>, 2020. The cancellation may affect BBA applicants who may wish to use March 2020 GSAT score to apply for the BBA International Program for Academic Year 2020 – Inter Portfolio 2. BBA International Program would like to make the announcement for applicants for Academic Year 2020 – Inter: Portfolio 2 as follow

1. The application schedule is **Maintained** as per announcement by Thammasat University regarding Admission for Bachelor of Accounting (International

Program) and Bachelor of Business Administration (International Program), Faculty of Commerce and Accountancy, Thammasat University for Academic year 2020 –

Inter:Portfolio 2. However, the interview will be conducted online. Please follow up on the detail of applicants eligible for Interview.

2. Students who intend to use the March GSAT score to apply for BBA International Program and have successfully paid application fee and wish to cancel application due to unavailability of GSAT score are eligible to get the application fee refund. BBA International Program will refund the application fee for applicants who want to cancel application. Applicants should perform the step:

2.1 Express your intention to cancel application and request for application fee refund with the following attached document as per 2.2 via Email:


